


Natural Hydrogen in Western Canada

- **REV is first-mover** into Natural Hydrogen in Alberta with the acquisition of the **Aden Dome Project** along the Alberta-Montana border in a district well-known for shallow gas production
- Aden is an advanced drill-ready target with highly encouraging historic data, freshly interpreted by REV geologists to be prospective for accumulations of Natural Hydrogen given multiple factors including intense fracturing and favorable basement geology

REV holds Canada's largest land package of permitted exploration ground for Natural Hydrogen with 3,726 sq. km in Saskatchewan

Jordan Potts, CEO: "Having just secured a massive land package with permits for Natural Hydrogen exploration in Saskatchewan, where discovery potential is considered very high, we are also keenly interested in neighbouring Alberta, which has an advanced hydrogen economy and a rapidly growing demand for new low-cost, clean energy given the province's emphasis on development of Al data centres."



Gold in Northern Quebec

- **REV is a significant landowner** in the heart of the increasingly prolific Chibougamau Gold Camp which now hosts over 12 million ounces across various categories, collectively owned by IAMGOLD and Northern Superior
- A work program has been initiated at REV's JMW Property where promising drill results from Gitennes (precursor company to REV) included a high-grade gold intercept in the sediments, an historically overlooked area on the property
- JMW is along the same trend as IAMGOLD's multi-million ounce Nelligan deposit 30 km to the east gold in sediments has been a key driver at Nelligan
